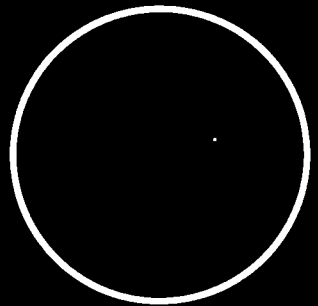

I GIVE AND BEQUEATH unto my niece Miss Ekaterina Petroff of 9 Portchester Square London W. 2 all my possessions for we always had our things, tools and materials in common use and possession. My account with the Post Office Savings Bank has been nominated to pass to my said niece on my decease and this nomination was registered by the Post Office on the eleventh day of July in the year of our Lord one thousand and hundred and fifty seven under the number A 494134. The balance at the National Provincial Bank Port Street London W. 1. of the current account which I hold jointly with my said niece together with two diamonds in a platinum chain deposited with the same Bank are to be hers. At this Bank my name is registered under the alternative spelling Tcheremissina.
