AT EDINBURGH the Fourteenth day of April one thousand nine hundred and ten the DEED hereinafter engrossed was presented for Registration in the Books of the Lords of Council and Session for preservation and is registered in the said Books as follows: - I MRS HELEN CATHARINE DOUGLAS or MACKENZIE residing at Alt-:nacoille, Shandon, Helensburgh, Scotland, Widow of Lieu-:tenant General Colin MacKenzie, Companion of the Bath, being desirous of settling the disposal of my means and Estate after my death do hereby give grant assign dispone convey and make over devise, bequeath and ap-:point to and in favour of Cuthbert Cooke Esquire at present living at Fairfield House, Leckhampton Road, Cheltenham, Miss Bertha Frances Baines, residing at Altnacoille Shandon, and James Steuart, Writer to the Signet, Edinburgh and such other person or persons as I may hereafter name or as may be assumed or appointed to act in the trust hereby created, and the acceptors and acceptor, survivors and survivor of the persons above named or to be named assumed or appointed as aforesaid (the said persons and their foresaids being hereinafter denominated "my Trustees") and the assign-:ees of my Trustees heritably and irredeemably the whole means and estate heritable and moveable real and personal of what kind or denomination soever and wheresoever situated at present belonging or addebted or which may belong or be addebted to me, or of which I shall be possessed or to which I shall be entitled, or over which I may have general disposing power by Will or any power of disposal or appointment at the time of my death (but excepting from this Conveyance the furniture, plenishing and others in the dwelling house at Altnacoille, Shandon, which I made over to

the said Bertha Francis Baines, my niece along with said house in the year Eighteen hundred and ninety eight) with the whole writs, titles, vouchers, securities and instruct-:ions of and concerning my said means and estate, and all that has followed or may be competent to follow thereon; But that in trust only for the uses, ends, and purposes after mentioned viz: - (First) For payment of all my just and lawful debts, deathbed and funeral expenses and the expenses of executing this trust; and I desire to be buried beside my beloved husband in the Grange Cemetery, Edinburgh it being my wish that my funeral shall be as simple and inexpensive as possible (Second) That my Trustees shall convey and make over to my grandson Cuthbert George Wilder Clogstoun at present serving under the Government of India in the Police Department in the Madras Presidency the lots of land belonging to me in the New Town at Muttah the new port of Calcutta called Town lots of Canningtown Muttah, near Calcutta, Bengal, or as the same may be otherwise described with all rights and pertinents thereof and I leave and bequeath the same to him accordingly, but in respect the title deeds of said lots cannot be found the said Cuthbert George Wilder Clogstoun shall have no claim against the residue of my Estate if a title to said lots cannot be completed: And further that my Trustees shall make over and deliver to, as I hereby leave and bequeath to my cousin Miss Mary Louisa Douglas daughter of the late Lord William Robert Keith Douglas, whom failing to her brother Charles Irvine Douglas to be disposed of according to any letter or Memorandum I may leave, all my pictures, books, jewels, plate, medals, but not the said furniture plenishing and others in the dwelling house at Altnacoille which I have already given to my said niece, or any Arti-:cles specially excepted by Memorandum or letters as in-:tended/

intended for others; And I direct my Trustees to make payment to each servant in my service at the time of my death and who shall have been in such ser-:vice two years previously to such death of a sum equal to one year's wages, and that over and above what may be due at my death to them. (Third) That my Trustees shall purchase from an Insurance Company or Companies the following annuities for the persons after named in so far as the same may not be purchased by me during my life viz for Miss Adelaide Germaine Catherine Douglas an annuity during her life of Seventy six pounds Sterling, to my cousin Miss Annie Cooke an Annuity of Seventy-five pounds during her life; To my niece the said Miss Bertha Frances Baines an annuity of One hundred and fifty pounds during her life and to Jessie Anderson my faithful maid an an-:nuity of Thirty pounds during her life, the said ann-:uities under this third purpose to be paid free of all duties to Government, and to begin as soon after my death as my Trustees can conveniently arrange for the purchase and to be paid half yearly and to cease with the last half yearly payment prior to the death of the annuitant: (Fourth) That my Trustees shall make payment so soon as the trust funds are available for that purpose to Edith Douglas, Margaret Douglas, Mary Catherine Grey Douglas now Ainger and Katherine Helen Douglas daughters of Henry Alexander Douglas late Bishop of Bombay or the survivors, equally among them of the sum of Three thousand pounds Sterling the children of any predeceasing being entitled to their parents share, and (Fifth) That my Trustees shall make payment to the Trinitarian Bible Society of a legacy of one hundred pounds free of duty the receipt

of the Treasurer to be a sufficient discharge (Lastly) That my Trustees shall pay and make over the whole residue and remainder of my means and estate to the said Mary Louisa Douglas whom failing to the said Charles Irvine Douglas, but subject always to any directions I may here-:after leave by any writing or letter of directions by me though not formally executed: And I hereby nominate my Trustees to be my sole Executors and Administrators: And I hereby declare that my Trustees shall have power of sale by public auction or private bargain and shall have power to appoint Agents or Factors who may be of their own number and who shall be entitled to suitable remuneration And I consent to the registration hereof for preservation In Witness Whereof these presents written on this and the preceding page by Upton James Rhind, Clerk to Messrs J.C. & A. Steuart, Writer to the Signet, Edinburgh are subscribed by me at Altnacoille aforesaid on the Thirteenth day of March in the year Nineteen hundred and two before these witnesses Robert Scott Moncrieff, Forty three Mardale Cres-:cent Edinburgh, and Robert Douglas Reid, Physician and Surgeon, Easterton, Helensburgh.
