ROBERT SANDERSON. RECORD OF INVT. VOL.64-5P. 325 20th MARCH 1920.

> At Edinburgh the Twenty fifth day of April One thousand nine hundred and nineteen the Deed hereinafter Engrossed was pre-:sented for registration in the Books of the Lords of Council and Session for preservation and is registered in the said Books as follows:-

I, Robert Sanderson, Artist, residing at number Six Forrest Road, Edinburgh, in order to settle my affairs after my death Do hereby Leave and Bequeath to my grand-daughter Florence Ray Russell, the sum of Twenty pounds Sterling, as soon as possible after my death, but without interest, in consideration of her services as my housekeeper, and provided that she is residing with me at the time of my death: And I Leave and Bequeath to my daughter Mrs. Rachel Sarah Joan Sanderson or Johnston, wife of Doctor William Johnston, Bloemfontein, South Africa, the framed portrait in oil of herself painted by me, and presently hanging on the walls of my house: And I Leave and Bequeath to my daughter Mrs. Caroline Isa Sanderson or Osborne, wife of Doctor Herbert Osborne of Pretoria, South Africa, the framed portrait in oil of herself painted by me, and hanging on the walls of my house: And with regard to the residue and remainder of my means and estate heritable and moveable/

moveable, real and personal, of what kind or nature soever or wheresoever situated presently belonging or which shall belong to me at the time of my death, I Leave, Bequeath Assign and Dispone the same equally to and between my five daughters, the foresaid Mrs. Rachel Sarah Joan Sanderson or Johnston and Mrs. Caroline Isa Sanderson or Osborne, and my other daughters Mrs. Robina Jacob Sanderson or Russell, wife of James Russell, Baker, Pitlochry, Mrs. Ada Henrietta Jacob Sanderson or Kewley, wife of Thomas Kewley, Sack Merchant, Hull, and Mrs. Amy Louisa Jacob Sanderson or Maclulich, wife of Doctor Peers Maclulich, sometime of Senekal, South Africa, but presently residing in London, and the survivors and sur-:viver of them; provided always that should any of my said daughters predecease me leaving lawful issue, such issue shall come in place of and take equally among them if more than one the share which would have otherwise fallen to their parent, but declaring that the jus mariti and right of administration of the husbands of my said daughters shall be excluded from my estate, and that the receipts and acknowledgments of my said daughters by themselves alone without the consent of their husbands shall be sufficient for my executors: And I nominate/

nominate and appoint my said daughter Mrs. Ada Henrietta Jacob Sanderson or Kewley, and John McLaren, Solicitor in the Supreme Courts of Scotland, Edinburgh, and the survivor of them to be my sole executors or executor as the case may be: with power to the said John McLaren to act as Law Agent in the premises: And I reserve my own liferent: And I revoke all former settlements executed by me: And I dispense with delivery: And I consent to the registration hereof and of any Codicils hereto for preservation: In Witness Whereof these presents written by Margaret Brass Garriock, Clerk to Messieurs Ramsay and McLaren, Solicitors in the Supreme Courts of Scotland, Edinburgh, are subscribed by me at Edinburgh upon the Third day of April Nineteen hundred and sixteen be-:fore these witnesses, Robert Ferrie Stevenson, and Joseph McIntyre Taylor, both Clerks to the said Messieurs Ramsay and McLaren.
